

TROOP OF EXCELLENCE

Girl Scouts of Michigan Shore to Shore's Troop of Excellence program was established in 2025 to recognize troops who provide Girl Scouts with exceptional experiences. Troops earning this recognition provide strong, balanced programs for Girl Scouts at all age levels. This prestigious distinction promotes girl/adult partnerships, girl planning, community service, and involvement with the greater Girl Scout community.

Troops who achieve the Troop of Excellence distinction will be showcased on GSMISTS social media and publications. They will receive a certificate and can purchase the Troop of Excellence patch to wear proudly on their vest or sash.

Troop of Excellence Program Details

- GSMISTS Troop of Excellence program spans the membership year – October 1 to September 30.
- Troops must complete all “Troop of Excellence Standards” requirements.
- Troops must also complete “Troop Choice Activities” requirements as follows:
 - Daisy troops must complete 5 troop choice activities.
 - Brownie and Junior troops must complete 7 troop choice activities.
 - Cadette, Senior, Ambassador, and Multi-Level troops must complete 9 troop choice activities.
- Experiences may only be counted towards fulfilling a single requirement.
- The expectation is that at least 75% of girls in the troop participate in a requirement to count the requirement (unless another percentage is specified in the requirements).
- The Troop of Excellence [online application](#) opens on December 1, 2025. Completed applications must be submitted by September 30, 2026. Late applications will not be accepted.
- Troops can purchase the Troop of Excellence patch after their online application has been approved by GSMISTS.

Troop of Excellence Standards

Registration and Training (all required)

- ☐ Membership registrations were completed by September 30, 2025 for returning members of existing troops or by the first meeting for new troops.
- ☐ Troop has at least 2 approved (registered member of Girl Scouts and background check approved) and appointed leaders.
- ☐ *GSMISTS New Leader Training* was completed by the troop leader (for new troops or new troop leadership). Available on gsLearn dashboard.
 - ☐ Not complete. Existing troop.
- ☐ *GSMISTS Troop Leader Refresher Training* was completed by the troop leader (for existing troops). Available on gsLearn dashboard.
 - ☐ Not complete. New troop/new troop leadership.
- ☐ Every volunteer registered as troop leader/assistant troop leader(s) completed *GSUSA Girl Scouts Child Abuse and Neglect Prevention Course*. Available on gsLearn dashboard.
- ☐ Every volunteer registered as a troop leader/assistant troop leader(s) completed at least one enhancement training. Training can be in person, virtual, or on gsLearn. Enhancement trainings include those listed in purple on the GSMISTS [Event Calendar](#).

Troop Planning and Communication (all required)

- ☐ Troop was displayed on the online Troop Catalog and was accepting of new members (girls and adults).

Financial Accountability and Product Program (all required)

- ☐ Troop established and maintained a bank account with at least two authorized signers, as required by GSMISTS guidelines.
- ☐ Troop submitted Annual Finance Report on time (on or before June 1).

Troop Choice Activities

Daisy troops must complete 5 troop choice activities. Brownie and Junior troops must complete 7 troop choice activities. Cadette, Senior, Ambassador, and Multi-Level troops must complete 9 troop choice activities. Provide a **brief description** of how the activity was accomplished in the space below each activity.

- ☐ A minimum of 50% of girl members and 2 adult members are renewed by June 30, 2026 for the 2026-2027 membership year.
- ☐ The troop participated in a recruitment event to encourage new girls to join their troop or to start a new troop.
- ☐ Troop members hosted a “Bring a Friend” troop meeting.
- ☐ The troop conducted at least 2 flag ceremonies, with at least 1 being a public flag ceremony (i.e. PTA meeting, community club meetings, ball game, etc.).
- ☐ The troop participated in an activity that promoted community awareness of Girl Scouts.
- ☐ The troop participated in at least 1 service unit event.
- ☐ The troop participated in at least 1 activity with another Girl Scout troop.

- ☐ Troop member selected and completed their own [Leadership Award](#).
- ☐ The troop completed their [Bronze](#) or [Silver](#) Award.
- ☐ The troop took at least 1 trip away from their regular meeting place for badge work.

- ☐ The troop went on an [age-appropriate travel experience](#).
- ☐ The troop participated in a [Program on Demand](#).
- ☐ The troop planned and completed a summer activity.
- ☐ The troop participated in an activity that encourages environmental stewardship.
- ☐ The troop participated in an activity that explores STEM fields (science, technology, engineering, and math).
- ☐ The troop invited a subject matter expert to speak on a badge topic.

- ☐ The troop learned about [SWAPS](#), created some, and distributed them.
- ☐ The troop learned about Girl Scouting/Girl Guiding in other countries.
- ☐ The troop [Shared Their Girl Scout Story](#) with GSMISTS. – showcasing something the troop did. If including photos make sure you have permission from parents/caregivers.

By submitting the online application, our troop verifies the information submitted is truthful and accurate. We understand the Troop of Excellence program is based on the honor system and promise that we have conducted ourselves in accordance with the Girl Scout Law.

Frequently Asked Questions

What time frame counts for the Honor Troop checklist activities?

Please only include activities your troop completes between October 1 and September 30 each year.

Do all girls in the troop have to participate in each activity we do to qualify?

We understand that sometimes an illness or other circumstance may prevent all girls from participating in an activity. Girls who were not in the troop at the time of the activity are exempt. Please do not include activities on the checklist in which fewer than 75% of girls participated.

When can Troop of Excellence patches be purchased?

Troops can purchase the Troop of Excellence patches after their [online application](#) has been submitted and approved by GSMISTS. The online application will be available annually beginning on December 1.

What counts as “participation” in the product programs?

At least 75% of the girls in the troop must participate in the product programs. Girls should set a goal and work toward it.

If my troop was not established when the Fall Treats & Reads program or Girl Scout Cookie Program was occurring can my troop still qualify to be a Troop of Excellence?

Yes, the troop can still qualify as a Troop of Excellence. On the [online application](#) there is the opportunity to request an exception from a “Troop of Excellence Standard”.

What does it mean to be “girl-led” and how would we demonstrate that?

Girl-led means that girls are playing an active part in figuring out the “what, where, when, how, and why” of their activities. While a Daisy and Ambassador troop can demonstrate this in different ways, the opportunity to help create their unique troop experience should be available to all girls. How did girls plan their camping trip, ceremony, or troop meetings? Were girls given a choice as to what badges to work on? Did older girls help run an activity for younger girls? These are all ways you can demonstrate the troop is girl-led.

Do fun patches count for earned badges and awards?

No. Badges and awards may include GSUSA badges, Bronze, Silver, and Gold awards, Leadership awards, My Promise My Faith awards, etc.

Can an activity meet multiple requirements, such as a STEM camp?

The intent of the Troop of Excellence program is to provide girls with a variety of activities. Please choose the single best category for each activity.

Does the troop leader have to be the person attending the service unit meetings to qualify?

We encourage you to share this requirement with all troop volunteers. The troop may be represented by any adult at the service unit meeting who can then report the information back to the troop leader/assistant troop leader.
